The APMG PPP Certification Program is an innovation of the Asian development Bank (ADB), the European Bank for Reconstruction and Development (EBRD), the Inter-American Development Bank (IDB), the Islamic Development Bank (IsDB), the Multilateral Investment Fund (MIF) and the World Bank Group (WBG) and part funded by the Public-Private Infrastructure Advisory Facility (PPIAF) with a shared vision of enhancing PPP performance globally. CP<sup>3</sup>P is a credential that every professional keen to get certified and enhance their career in the world of Public-Private Partnerships should aim to achieve.

Cost of meeting current infrastructure deficit in Nigeria is put at about \$30 billion (N10 Trillion) per annum. And to bridge this huge gap, there is need to spend this amount consistently for the next 10 years. The Federal Government of Nigeria has placed much attention on infrastructure development but fund is short. In its recent effort at infrastructure development and to involve the private sector, it has signed into law Executive Order No 7 on Road Infrastructure Development and Refurbishment Investment Tax Credit Scheme. Due to the Complexities of the Requirement of infrastructures using the Public-Private Partnership (PPP) model, a world-class training and certification is required. This is provided by the APMG PPP Certification Programme.


